RENTAL RATES

- Clippers - \$5.00 per day plus \$100.00 deposit.
- Blades (for clippers) - \$5.00 per set per day plus \$25.00 deposit.
- Scales - \$5.00 per day plus \$100.00 deposit.
- Trim Stand/Table - \$5.00 per day plus \$25.00 deposit.
- Gaga Pit, games, and other equipment - \$5.00 per day plus \$100.00 deposit.

If renting multiple items, the deposit is for the highest amount. The deposit is a one-time (not daily) fee and is refundable.

If the equipment borrowed is by a club, only an "officially" recognized club manager is allowed to pick up the equipment; in this case, there are no rental fees for the equipment. Deposit is still required.

AGREEMENT

I agree to keep the above-equipment a maximum of three days, unless otherwise directed by the 4-H County Extension Agent. I realize the above equipment must be returned by noon on the last day of the agreement, with the exception of during the month of January, when you will ONLY be allowed to rent the equipment for a total of 24 hours, unless authorized by the 4-H County Extension Agent. I also realize that there will be a \$25.00 per day late fee if the equipment is not returned by the time specified. _____ (initials)

I also agree NOT to alter or damage the equipment in any way. I realize if the equipment is altered or is damaged, I will be responsible for having the equipment repaired at an approved professional service business. Nueces County 4-H Council will NOT be responsible for any loss or damage to any property or any material belonging to the above 4-H member/parent/leader/club manager. _____ (initials)

I agree to clean and disinfect the equipment before returning it to the Nueces County 4-H Office. Equipment and item identification number **MUST BE VERIFIED** and the equipment returned in an acceptable manner by the 4-H County Extension Agent. Failure to clean and disinfect the equipment completely before returning it will result in a cleaning fee of \$25.00 per item to be paid to the Nueces County 4-H Council. If there is a second offense of this type, the 4-H member/parent/leader/club manager **WILL NOT** be allowed to rent or use any of the 4-H equipment again.
